NOAA's 105th Basic Officer Training Class (BOTC) has been temporarily appointed by Secretary Evans. The class of 14 will report for duty tomorrow morning in Norfolk, VA. Annual Review:

The 2004 Annual Review of the Lineal List will take place in Shepherdstown, WV, March 15-March 19, 2004. Documents for OPF inclusion will be accepted through Friday, March 5, 2004. Anything received after that date will not be included in your OPF during the Annual Review.

Medical Notes:

Periodic medical examination memorandums which indicate an incomplete medical file will be placed in your official medical file. Your official medical file is confidential and is reviewed for medical purposes only.

CPC REFTRA:

Just as it sounds, this section will serve as Refresher Training for subjects including promotion and medical qualifications, payroll issues, TDY travel and the assignment process. This week: Permanent Change of Station (PCS)

- * The Travel Information Form (NOAA Form 56-26) referenced in forthcoming assignment memorandum, is crucial to determining travel and transportation entitlements. This form must be completely filled out and endorsed through the chain of command before submission.
- * Typically, PCS orders will be issued not less than eight weeks prior to the detachment date. A packet of pertinent information and instructions will be attached.
- * If commercial travel is authorized on the orders, reservations are the responsibility of the traveler(s). Reservations must be made through SATO or another travel agency under government contract. A copy of orders must be submitted to SATO for direct billing. If you must purchase an airline ticket, use your government issued travel credit card. Tickets purchased with personal credit cards are not authorized; therefore you will not be reimbursed.
- * If it's not on your orders, it's not authorized. Travel for NOAA Corps officers is governed by the Joint Federal Travel Regulations (JFTR) which prescribes per diem, travel and transportation allowances, relocation allowances, and certain other allowances of Uniformed Service members. CPC personnel continue to serve as voting members of the Per Diem, Travel and Transportation Committee, which publishes the JFTR.
- * Always submit endorsed orders and change of address forms to CPC immediately. Delayed submission of endorsed orders can affect pay and entitlements.
