From the Director's Desk

Happy Thanksgiving

Congratulations to all officers assigned to NOAA's aircraft and ships after another safe and successful field season. Some of NOAA's aircraft and ships will continue to operate over the holidays: we appreciate their dedication to mission and the nation while the rest of us are able to spend time with our families and friends.

Mandatory Retirement - 33USC 3043

Officers serving below the grade of rear admiral (lower half) shall retire on the first day of the month following the month in which the officer becomes 62 years of age.

The President may defer the retirement of an officer serving in a position that carries a grade above captain for such period as the President considers advisable, but such a deferment may not extend beyond the first day of the month in which the officer becomes 64 years of age.

Mandatory retirement is based on age not years of commissioned service. However, the Officer Personnel Board performs an annual review of each officer's personnel files and makes recommendations to the Director, NOAA Corps, regarding an officer's progress and fitness. The OPB has the statutory authority to recommend an officer in the permanent grade of captain or commander be transferred to the retired list; and an officer in the permanent grade of lieutenant commander, lieutenant, or lieutenant (junior grade) who is not qualified for retirement, be separated from the service. In short...there is no 30 year mandatory retirement. That law was repealed many years ago.

The 29 November, 2004 Navy Times has a very good article/interview with the Chief of Naval Operations Admiral Vern Clark titled "We are challenging every assumption." Admiral Clark provides his vision of the Navy in the 21st century. Most of the article is dedicated to people not things. Admiral Clark is calling this reshaping of the force "Human Capital Strategy." In the article Admiral Clark says "it's fundamentally how you acquire people…how you grow and develop them…and the way you will retain the intellectual capital that you need to run your organization." He provides very straightforward common sense ideas, however, you feel the passion and get the feeling that he will execute those ideas. I recommend you find a copy and read it.

THRIFT SAVINGS PLAN OPEN SEASON

The current Thrift Savings Plan (TSP) open season for changes to contribution elections runs through December 31, 2004. The maximum percentage of basic pay for contributions increased to 10% for CY 2005. Any amount (in whole percentages) of special, incentive, and bonus pay may be elected for TSP contribution. Special pay includes sea pay and diving pay. Incentive pay is Aviation Career Incentive Pay, and Bonus Pay covers the Career Status Bonus. You may start, increase, reduce, or stop contributions in any of the four pay categories during the open season. The next open season is scheduled to begin 15 April, 2005.

Though pay deferral changes may be requested through 30 December, 2004, all changes within this open season will affect pay beginning either in December, 2004 or January, 2005.

Increases to basic pay deferrals received on or before Friday, 3 December will become effective with the 15 December, 2004 pay day.

Requests received between Monday, 6 December, 2004 and Thursday, 30 December, 2004 will effect deductions beginning with the January 14, 2005 pay day. New monthly contribution amounts, based on December deductions, are transmitted to TSP accounts on

1 January 2005, and those beginning in January arrive in TSP accounts on 1 February 2005.

To make changes to your contribution (or pay deferral) elections, you may e-mail the information to the NOAA Corps Payroll Unit in Topeka, mail in or fax a written TSP-U-1 form, When using the printed form, ensure you use the TSP-U-1 form. The TSP-1 form is the civilian version of the plan and cannot be accepted.

If submitting change information via e-mail, inclusion of your SSN is neither necessary nor advised. Please send your e-mail request to both J.
