# From the Director's Desk

The 109th Basic Officer Training Class reported for duty on Thursday February 9, 2006 at the Marine Operations Center, Atlantic. Fifteen temporarily appointed ensigns have now joined the NOAA Corps. The 109th BOTC will be spending next week in Silver Spring, MD and they are scheduled to receive briefings from the representatives of NOAA headquarters and Line Offices. This increase in overall strength allows us to promote officers based on 288 and creates twenty two vacancies on the lineal list. CPC will forward a promotion package to the Secretary next week requesting he sign twenty two commissions for the following vacancies: three captains, four commanders, six lieutenant commanders, three lieutenants, and six lieutenants (junior grade). After the package leaves CPC it will take approximately two weeks to get the commissions signed by the Secretary.

## Oath of Office

A temporary appointment of an ensign, into the NOAA Corps is a multi-step process, here are four of the most important steps: (1) candidate must be nominated by the Officer Personnel Board; (2) candidate must satisfactorily pass the requisite physical examination; (3) the Secretary must approve the OPB recommendations and sign a letter stating such; and (4) the candidate must receive the oath of office. All steps must be completed before the candidate is commissioned in the NOAA Corps. Only those agents authorized by law may issue the oath of office, of which the Director, NOAA Corps, Director, Marine and Aviation Operations Centers, the Director, Commissioned Personnel Center, and the Deputy Director, Commissioned Personnel Center have been delegated that authority. We drafted legislation seeking a change to this law, allowing all commissioned officers authority to deliver the oath of office, but until such time, only those designated may do so.
