Initial Flight Training Opportunities

The NOAA Corps will be selecting two officers from the fleet to transition into Aviation during the 2009 calendar year. Start dates for flight training will be approximately January 2009 and June 2009 with some flexibility to accommodate rotation dates. Flight experience is not required to be considered for this opportunity. Only candidates that will begin flight training with less than 6 years of TOTAL service toward retirement will be considered during this selection.

As part of the application process, officers desiring to be candidates for selection into the aviation program must produce or accomplish the following:

1. Complete all sections of NOAA Form 56-43: Application for NOAA Corp Aviation Program <u>http://www.noaacorps.noaa.gov/cpc/forms/pdfforms/noaaform_56_43.pdf</u>

2. Complete a USCG Class I flight physical

3. Complete ASTB through a Department of Defense recruiting center. For general information on the test go to the following site:

4. Provide a recommendation for aviation selection in Section 10 (Potential) of the applicant's Officer Evaluation Report (NOAA Form 56-6A)

Completed aviation application packets must arrive at the Commissioned Personnel Center (CPC) by COB, March 3, 2008. AOC will be responsible for conducting interviews between March and May for all applicants that meet the application requirements. Once the interview process is completed, AOC will be responsible for forwarding the completed interview results to CPC. An Officer Assignment Board will convene on June 5, 2008 to select officers for initial flight and navigator training.

Important Information for Officers Eligible for Promotion Year 2008

All NOAA Corps officers are required to have a current (annual or 5 year periodic) physical examination and a current dental exam (class I or class II) on file with the Medical Administration Branch at CPC. The deadline for the submission of medical records for the 2008 promotion year is January 31, 2008. Documentation submitted after the deadline will not be considered for the 2008 promotion year. This may require you to plan and get your physical or dental exams completed before they expire.

Officers should contact LCDR Hobson-Powell in the Medical Administration Branch via E-mail (Elizabeth.hobson-powell@noaa.gov) over the next few weeks to ensure that you have a current periodic physical examination and all required medical documents are on file.

PLEASE NOTE: Upon review of your medical documents, the Medical Administration Branch will notify you via E-mail if additional documents are required.

Instructions on how to order the uniform:

1. Click on the following USCG Uniform Distribution Center website: <u>https://webstore2.techgap.com/uscgudc/login.jsp?client=uscgudc</u>

2. Click on "Request/Change Login & Password" and complete Login form. NOTE: You will need to have your 7-digit Employee ID (EMPLID) number available in order to generate an account.

3. After submitting the form, you will receive a confirmation e-mail (usually within 24-hours) that contains your User Name and Password.

4. Once you have your User Name and Password, you will need to return to the USCG Uniform Distribution Center website to place your order.

5. Click on the following links to order ODU items:

ODU Uniforms (i.e., trousers, coat, t-shirts)

ODU Accessories and attachments (i.e., black belt, buckle, name tape (Comments: Type your last name), ODUNOAA, trouser blouser, sew-on collar device). NOTE: It is cheaper and easier (one stop shopping) to order your Name and NOAA Corps tapes from the USCG UDC vs. the ACO.

Shoes/Socks (i.e., socks).

Super Boot II (NOTE: Equivalent black boots that meet ANSI Z41-1999 requirements may be purchased in place of Super Boot II)

NOAA Corps ball caps are in stock and will need to be ordered from the ACO Custodian using the 2008 ACO Insignia Order Form located on the following website: http://www.noaacorps.noaa.gov/cpc/forms/pdfforms/insignia.pdf

6. Once you submit your order, you will receive a confirmation e-mail providing order acknowledgment information.
