# Director's Message

The promotion boards were delayed two months last year solely due to the delay in the submission of OERs. Officers have 45 days to provide a rebuttal for an OER, so promotion boards can not be held until at least 45 days after the OERs have been received at CPC. The deadline for paperwork to be entered into the OPFs is January 15th, 2008, no waivers will be granted to this deadline. This is the first step in avoiding another long promotion process as experienced in 2007.

Documents include all training certificates, approved awards (nominations do not go in your OPF), service reports, biographical sketches, resumes, and OERs. OERs must contain all the required original signatures (no copies or scans), must not contain any restricted information (See page 6, Form 56-6A), and must be consistent between the comments and marks provided.

(Note: the deadline for medical records to be received by the medical department is 31 January.)

#### Award Nominations

#### NOAA ACO Junior Officer of the Year Award

The National Association of Commissioned Officers requests nominations for the NOAA Corps, Junior Officer of the Year. NOAA Corps officers who are promoted to lieutenant

commander during the calendar year are eligible for the award.

#### NOAA ACO Science Award

The National Association of Commissioned Officers requests nominations for the NOAA ACO Science Award. Any NOAA Corps officer, or member of another uniformed service assigned, detailed, or attached to NOAA, who has distinguished him/herself by making outstanding scientific contributions that distinguish the individual above those performing similar services are eligible.

#### NOAA ACO Engineering Award

The National Association of Commissioned Officers requests nominations for the NOAA ACO Engineering Award. Any NOAA Corps officer, or member of another uniformed service assigned, detailed, or attached to NOAA, who has distinguished him/herself by making outstanding engineering contributions that distinguish the individual above those performing similar services are eligible.

#### Submission Procedure

A nomination for a NOAA ACO award shall consist of at least two pages, the first a cover memo addressed to the National ACO and containing the name, grade, duty title, and job description of the nominated officer. The following page(s) shall be the personal comments of the supervisor, which reflect the basis for the nomination.

All commands and field offices are encouraged to submit officer nominations for these awards. Selections for awards will be made by the Executive Committee, National ACO on January 12th, 2007. Please submit nominations to LCDR Mark Wetzler, President of the DC Area Association of Commissioned Officers via email, <u>mark.wetzler@noaa.gov</u>, by COB January 11, 2007. In the nomination email please have the supporting files attached as .PDF or readable by Microsoft Word. The subject line of the nomination email should be Junior Officer of the Year, Science Award, or Engineering Award.

Junior officers with civilian supervisors are encouraged to forward them this information.

#### Watchstanders Needed for National Operations Center

The NOAA Homeland Security Program Office in Silver Spring, MD is seeking 0-2 and higher ranking officers on assignments within the National Capital Region to serve as part time watch standers at the DOC NOAA Desk at the Department of Homeland Security (DHS) National Operations Center (NOC) in Washington, DC.

The mission of the NOC is to integrate DHS and interagency planning and operations coordination in order to prevent, deter, protect, and respond to terrorists threats/attacks or threats from other man-made or natural disasters. The NOC is a 24x7, multi-agency operations center that collects all-threats and all-hazards information across the spectrum of federal, state, local, tribal, private-sector, and other key sources. Its mission is to be the primary national-level hub for domestic situational awareness, common operating picture, information fusion, information sharing, communications, and operations coordination pertaining to the prevention of terrorist attacks and domestic incident management. The NOAA Desk is considered one of the critical department/agency desks within the NOC, providing a wide range of environmental information and forecasts from NOAA sources. The Desk is staffed by part-time watch standers from across line offices in the DC area, performed as a collateral duty, under the supervision of a senior desk officer on staff of the NOAA Homeland Security Program Office.

This opportunity provides an officer the chance to work in the Nation's premier interagency operational center where all federal departments and agencies are represented, to constantly maintain situational awareness of homeland security and all-hazards response across the nation. Exposure and visibility to senior officials in the Department of Homeland Security as well as other departments is provided. Volunteers are expected to be available for 1-2 eight hour day shifts per month, approved by their supervisor. Expansion beyond that availability is sought during times of crisis response at the NOC. Secret clearance is required. Training will be provided by the Senior Desk Officer.

#### Administrative Oversight of Career Status Bonus Eligibility

It has recently been discovered that, due to an administrative oversight by the PSC (Coast Guard Personnel Service Center) not all NOAA members have been notified of their eligibility to the CSB (Career Status Bonus).

PSC is responsible for tracking the entitlements for both Coast Guard and NOAA personnel, however, for a period of time this service has not been provided to NOAA officers. Upon identifying the error, the NOAA Corps Payroll Unit asked PSC to check each NOAA member to determine their eligibility for the CSB. PSC is now contacting all NOAA members that were eligible to the CSB during this time. If you have previously "declined" the CSB then you may disregard any correspondence regarding it and nothing will change.

In the future, each NOAA member that is eligible for the CSB will be notified at the appropriate time.

# **TRICARE:** Certain Survivors of Deceased Active Duty Members; and Adoption Intermediaries

On January 19, 2007 a final ruling regarding Section 715 and Section 592 of the National Defense Authorization Act for Fiscal Year 2006 (NDAA FY06) was implemented. Under Section 715, the time frame has been extended for certain dependents of active duty service members who die while on active duty for more than 30 days to remain eligible for TRICARE medical benefits at active duty dependent rates. Section 592 modifies the requirement for those intermediaries who provide adoption placements. Moreover, this rule administratively clarifies the eligibility provisions regarding those placed in the home of a member or former member in anticipation of adoption; and those placed in the legal custody of a member or former member.
