Effective January 1, 2013, NOAA Corps officers assigned to NOAA ships may elect not to occupy shipboard government quarters regardless of the physical location of the ship. The Basic Allowance for Housing (BAH) shall begin the day the officer refuses quarters. The Refusal of Quarters memorandum shall continue to be routed through the Commanding Officer to CPC in order to start the allowance. This change is not retroactive.
