#### **Director's Message**

In the last issue of the Cyberflash, we announced the Senate passage of the National Oceanic and Atmospheric Administration Commissioned Officer Corps Amendments Act of 2013. In light of the fact that we have legislation that is of personal and professional interest to all NOAA Corps officers making its way through the legislative process, I wanted to provide this guidance regarding our responsibilities with respect to our interactions and lobbying constraints while speaking in our official capacity as NOAA Corps Officers.

Under the law, including the Anti-Lobbying Act, NOAA (as an agency or individuals working for the agency) cannot direct our staff or anyone outside of the agency to engage Congress to specifically support or not support any piece of legislation. While non-governmental organizations may organize letter writing efforts and coordinate other efforts, we cannot. All we can do is report on the status of the bill, the process, educate our officers and partners about the issues and the content of a bill.

Please exercise the appropriate discretion and adherence to our legal obligations with respect to any legislation affecting the NOAA Corps as we interface in an official capacity with other individuals within and outside of our organization.

Secondly, as per NOAA Corps Directives 06601, NOAA Corps Officers are required to have a telework agreement approved by their supervisor and on file to be eligible for telework. A link for the Department of Commerce Policy and the associated forms can be found here:

### **OMAO Call for Training Proposals**

How to address your training needs: Interested officers need to submit their proposals to cpc.training@noaa.gov.

Submissions are due: No later than March 28, 2014.

**Training dates:** All requested training needs to commence no sooner than May 1 and be completed by September 30, 2014.

**What should be included in the proposal:** To expedite the review of your proposal, please include the following specifics for the review panel:

#### Cost in terms of:

- Time and class dates for your proposed training
- Travel costs required
- Tuition and fees for the training opportunity

#### Impacts to maximize:

- Officer professional development
- Improve mission efficiency
- Meet organizational needs
- Attach a memo from your supervisor indicating concurrence with your training request

**What happens after March 28:** Your submissions will be collated as they are received. In mid-April, the panel will review submissions and determine priorities for funding. This time line is approximate.
