SUBJECT: Standards of Conduct

As Director, I want to ensure all NOAA Corps officers are familiar with, and faithfully observe the laws and regulations pertaining to ethics as well as appropriate standards of conduct for federal employees. I expect NOAA Corps officers to exercise appropriate judgment at all times and in all areas, and adhere to policy regarding harassment, fraternization, drug and alcohol use, and the use of government property and equipment. It is incumbent upon each of us to understand the directives, regulations and policies that apply; ensure our actions and decisions are guided by them and know we are responsible and accountable for our professional and personal behavior.
