Appointments at White House since July 29, 2005.


I had an opportunity to meet the 108th BOTC class this week. The class of 15 new officers will be training at the Kings Point Merchant Marine Academy until November 2005. BOTC 108 will replace officers of the 104th BOTC who will be rotating to their shore assignments this December after two years at sea.

Starting with the next refresher training class, scheduled for October 2005, the Commissioned Personnel Center will be initiating a two or three day command and executive officer training program. The program will consist of a complete review of the NOAA Corps Directives Manual concentrating on the promotion process (Officer Evaluation Report-OER training), assignments, medical, discipline, uniform, protocol, budget, and legal issues to mention a few. The Office of General Counsel has also agreed to participate during this refresher training period and at all subsequent refresher training classes.

The Commissioned Personnel Center is planning for the roll out of the new Officer Evaluation Report. We are in the process of devising a training regimen and we will be looking for a volunteer from each of the three centers to participate in a formal training session at Silver Spring. These officers will act as the liaison for their respective center

answering questions which may arise after the new evaluation report is instituted.

Lieutenant Commander Anne Lynch has been reassigned as the NOAA Corps training officer at the United States Merchant Marine Academy, Kings Point, New York. LCDR Lynch will be performing both training officer and assignment coordinator duties for a couple of months until her replacement arrives at the Commissioned Personnel Center.

Record of Emergency Data (NOAA Form 56-14)

This extremely important form is to be used by you to show the names and addresses of your spouse, children, parents, and any other person(s) you would like notified if you become a casualty, and to designate beneficiaries for certain benefits if you die. IT IS YOUR RESPONSIBILITY to keep your Record of Emergency Data up to date to show your desire as to which beneficiaries will receive certain death payments, and changes to your family or other dependents status; for example, as a result of marriage, civil court action, death, or address change.

FedRooms is the new way, the easy way, for Federal government travelers to find hotels.

For most Federal travelers, finding hotels can be a challenge. You search and compare, only to find that the hotel you selected is not within per diem. Now there is an easy answer: FedRooms (the enhanced Federal Premier Lodging Program, formerly known as FPLP). Simply go to www.gsa.gov/fedrooms and click on "preferred hotels" to search more than 2,500 hotels that all meet Federal government criteria. Then click or call and **ask for the FedRooms rate**-and you are done. It is Federal lodging, made easy.
