Director's Message

Are you a decisive a leader? I am sure we can all think of examples where work has come to a grinding halt because no one is willing to make an important decision. Decisiveness resolves matters and clears the deck for action. During this week's meeting of OMAO's Executive Leadership Council, I am part of the team making decisions that will drive the organization's future.

The NOAA Corps Leadership Development Framework, under Leading Performance and Change, defines decisiveness as follows.

Decisiveness - Leaders make well-informed, effective, and timely decisions, even when data are limited or solutions produce unpleasant consequences. They involve others in decisions that affect them, generate promising solutions, and consistently render judgments with lasting, positive impact.

Decisiveness is the ability to make prompt decisions while ensuring they are clear and understood. We will make numerous decisions, both popular and unpopular, in our careers. Consider all the information. Make the decision which has the greatest possibility of impact and success, and stand by it. There will also be times when additional information will cause a change in the decision. Today, this can be perceived to be a negative trait. I, however, believe it can be a sign of good leadership if that change brings greater good to the organization.

Here are a few examples I believe evidence decisive leadership behaviors.

A leader takes time to fully understand all options before making or promoting a decision. A leader makes decisions in a timely manner.

A leader makes decisions that are logical and consistent with business priorities and the core values (honor, respect, and commitment) of the organization.

A leader makes difficult decisions when no one will, and communicates a rationale for the decision.

People are more apt to follow a leader's aspirations if the leader exhibits decisiveness. Take some time to evaluate your decision-making. Could you be more decisive? The path we shape for ourselves and the ones we lead is based upon decisions. Be resolute today.

When submitting records (medical or personnel) records to your OPF/OMF file online, please follow the guidelines listed to ensure smooth processing of your documents:

- Submit only PDF documents
- Name the PDF documents (last name and the date on the document)
- Do not submit images
- Do not submit Zip files
- Please submit only one document per OPF Fix ticket.

Taking these steps will ensure that CPC doesn't overlook a file and will allow for better tracking. Thank you for your cooperation.

NOAA Association of Commissioned Officers Annual Awards Nomination Season

The NOAA Association of Commissioned Officers administers the annual Junior Officer of the Year, Science, and Engineering awards. The ACO recognizes the wide range of accomplishments and contributions of NOAA's uniformed personnel, and encourages all commands consider nominating officers for these honors. <u>Nominations for the 2010 awards are due by December 3, 2010</u>.

Junior Officer of the Year

This award is presented annually to a single NOAA Corps officer, below the grade of lieutenant commander, for outstanding contributions to NOAA, outstanding performance, and/or the positive reflection cast upon the Corps. NOAA Corps officers who are promoted to lieutenant commander during the calendar year are eligible for the award.

Science Award

The ACO Science Award recognizes officers who make outstanding scientific contributions which distinguish them above their peers. All NOAA Corps officers and members of other uniformed services assigned, detailed, or attached to NOAA are eligible.

Engineering Award

The ACO Science Award recognizes officers who make outstanding engineering contributions which distinguish them above their peers. All NOAA Corps officers and members of other uniformed services assigned, detailed, or attached to NOAA are eligible.

Nomination Procedure

A nomination for a NOAA ACO award shall consist of at least two pages. The first page shall be a cover memo addressed to the National ACO, stating the name, grade, billet title, and job description of the nominated officer. The following page(s) shall be the personal comments of the nominator, which reflect the basis for the nomination. Nominations should include a detailed description of the officer's duties and accomplishments, and the positive impact of those achievements on the Agency and the Service.

All commands and field offices are encouraged to submit officer nominations for these awards. Candidates for Junior Officer of the Year must be nominated by a supervisor in their chain of command, while the Science and Engineering awards nominations may be made by the supervisor or any commissioned officer. Please submit nominations via e-mail to <u>matthew.glazewski@noaa.gov</u>, by COB December 3, 2010. In the nomination email please have the supporting files attached as .PDF or readable by Microsoft Word.

The subject line of the nomination email should be "Junior Officer of the Year Nomination," Science Award, or Engineering Award as appropriate. This will assist the selection committee with accurate tracking and sorting of the nominations. Junior officers with civilian supervisors are encouraged to forward them this information.

November 28, 1934

Nov. 28, PIONEER sighted yacht flying distress signal - vessel had disabled engine and was taken in tow off Pt. Vicente, CA. Coast and Geodetic Survey Bulletin, No. 235, p.8. December 1934.
